Validata™ is ready to receive May 2024 extracts

9-month SHS Statistical Summary reports

How to add a newborn baby to mother's support period

Has your client recently given birth to a baby? Are you supporting both the parent and child within your agency, where both are receiving a direct SHS service, e.g. accommodation support? If so, then the baby is a client of your agency and you are required to open a support period for the baby.

To add a baby to an open support period, you will need to add the child's information through the Create new relationship tab in SHIP. Once completed, you will need to select the date that the support period commenced to access the family's open support period. It is important that you state the start date of the support period for the baby as the day when the direct SHS service was provided to the baby, e.g. the first day that accommodation was provided. You will need to manually enter data into the relevant support period tabs from left to right until all tabs are completed.
